

# INITIAL APPLICATION FOR THE TEXAS SOCIETY OF PROFESSIONAL SURVEYORS DALLAS CHAPTER 5 JOHN PIERCE EDUCATIONAL ASSISTANCE FUND

**Intent:** The John Pierce Education Assistance Fund (JPEAF) was established by Chapter 5 to provide financial assistance for collegiate instruction within the practice of land surveying in Texas to well deserving Dallas/Fort Worth area applicants.

## **Qualifications:**

- 1) NEW: TSPS Dallas Chapter 5's area consists of Dallas, Collin, Ellis, Fannin, Grayson, Hunt, Kaufman, and Rockwall Counties. An applicant must:
  - a. Have a current home address within the Chapter 5 area, or
  - b. Currently work at or mobilize from a surveying company's office within the Chapter 5 area.
- Applicant must be currently enrolled as a part time student at a College or University Surveying Program or surveying-related course of study or, enrolled as a full-time student, or accepted for enrollment in a College or University Surveying Program or surveying-related course of study.
- 3) Applicant must be on a path to certification or licensure as a CST, SIT or Texas RPLS.

## Supporting documentation required:

- 1) This completed, signed, and dated Initial Application.
- 2) Current High School or College transcript.
- 3) In two double-spaced typewritten pages or less, describe the following:
  - a. Brief autobiography
  - b. Career plans
  - c. Reason for applying for this scholarship
  - d. Reason for choosing Land Surveying as a career
- 4) Letter(s) of recommendation from your current or former employer.

### **General information:**

To be considered for a particular semester, applications must be received by the following deadlines:


Fall Semester	September 15
