Qualifications:

- 1) **NEW: TSPS Dallas Chapter 5's area consists of Dallas, Collin, Ellis, Fannin, Grayson, Hunt, Kaufman, and Rockwall Counties. An applicant must:**
 - a. **Have a current home address within the Chapter 5 area, or**
 - b. **Currently work at or mobilize from a surveying company's office within the Chapter 5 area.**
- 2) Applicant must be currently enrolled as a part time student at a College or University Surveying Program or surveying-related course of study or, enrolled as a full-time student, or accepted for enrollment in a College or University Surveying Program or surveying-related course of study.
- 3) Applicant must be on a path to certification or licensure as a CST, SIT or Texas RPLS.
- 4) You must have been previously awarded a JPEAF scholarship to use this version of the application.

Supporting documentation required:

- 1) This completed, signed, and dated Application.
- 2) College transcript showing passing grades for all courses previously supported by the JPEAF.

General information:

To be considered for a particular semester, applications must be received by the following deadlines:

Fall Semester	September 15
Spring Semester	February 15
Summer Semester	June 15

Applications received after this deadline ***will not*** be considered. Applicants ***will not*** be notified of a missed deadline.

The number and amount of any financial assistance will be determined solely by TSPS Chapter 5.
